## **TDF AND EFIDIS SIGN A BLANKET AGREEMENT DESIGNED TO ENHANCE MOBILE COVERAGE IN THE PARIS METROPOLITAN REGION**

TDF and EFIDIS announce they have signed a blanket agreement providing for TDF to offer mobile network operators facilities to install their 3G/4G equipment on rooftops of EFIDIS-managed buildings. EFIDIS, a SNI group company, is a big social housing player in the Paris region.

This agreement covering 770 Paris region buildings including a hundred or so in inner Paris, will ramp up the density of TDF's existing rooftop points. Furthermore, it bolsters the over ten year-long fruitful teamwork between TDF and SNI while underscoring the appeal of TDF's offering to real estate management firms.

EFIDIS will join a community of social housing organizations that call on TDF's expertise in hosting telecoms equipment thereby boosting the value of their properties. EFIDIS builds and manages 54,000 social housing units throughout 200-plus communities. It also operates help-to-buy schemes for the units' tenants.
